# Mumbai & Bengaluru both don't have elected Corporators for over two years



t is unfortunate that both major cities in the country, Mumbai and Bengaluru, do not have elected Mayor



and Corporators for over two years. Unlike Assembly or Parliament which are more lawmakers who bring in policies and laws, it is the Corporators that are more directly involved with citizen's daily quality of life. Thus depriving the citizens of their right to better quality of life through their elected Corporators is a major violation of fundamental rights as enshrined in the Constitution for their development.

Both the governments of Maharashtra and Karnataka do not want to let go their hold on the two Corporations which have big budgets even bigger than those of some States and involvement in having a say in their respective city's development. Further, the number of Corporators in both the cities is much more than those of Legislators and Parliamentarians. The area for each constituency of a ward is small and much easier to handle for development.

In fact, they forget that with the hugh number of Corporators, they will be able to build a big line-up of leaders for their party without which the party will not be able to grow. Unfortunately, the politicians would not like to let go their hold on the budgets of the wards in their legislative and parliament constituencies.

Finally, due to no elected Corporator or a Mayor, there is no accountability by the officers including the Municipal Commissioner who are accountable only to the party in power in the State.

# **Hospital Healthcare Delivery**- Poor Patients

n the earlier issues under the series of 'Stories of Good Governance' we have seen the examples of good governance in diverse fields at village level, in government administration, at school level etc. We have seen good governance at Wablewadi ZP School at Shirur Taluka in Pune District, at Village Level by South Orissa Voluntary Action - SOVA in the poorest district of Koraput in Odisha, Vibrant Gram Panchayat at Orkun Mittur and Dibburahalli in Karnataka, Village Patoda a tehsil in Beed subdivision of Beed district, Maharashtra, Super-Efficient Functioning Bureaucracy - IAS Office FDA Commissioner Mr Mahesh Zagade.

In this article, we will have a look at the Good Governance in the field of Hospital Healthcare Delivery. This example is from my own experience of managing a reputed Hospital. There are many areas of healthcare delivery which need good governance. Let us see the area of free treatment to poor patients as per the government order. As per the (then) order, every charitable



hospital must give complete free treatment to poor patients (annual income up to Rs. 50,000/-) and 50% concessional treatment to economically weaker (annual income up to Rs. 1,00,000/-). As per my observations and as often reported by the Charity Commissioner and the Media from time to time, this order is often flouted and misused by many hospitals (including reputed hospitals). Often the drivers and servants and friends of the Trustees and staff were given this facility even though they were having much higher income.

At our hospital, we used to thoroughly check their ancillary documents like electricity bill, telephone bill, house ownership and area, place of working etc. to make sure they are eligible. One Minister had appointed an agent to wholesale give this facility to the people from his constituency contd. on Page 4

contd. from Page 1 in upcountry. That agent used to be in the hospital all the time, arranging the well-being of his subjects and their documentation. Based on our factual scrutiny, we found out that the rules are blatantly flouted. So we refused to accept the patients under this category. The Minister personally called me and to my horror, he used a very loud and abusive threatening language, in sharp contrast to his public image. We did not budge. He complained to the Charity Commissioner and through them put pressure on us. Charity Commissioner officially sent us a stricture and warned us of serious consequences for flouting the rules.

We took up the challenge and did not budge from our position. We officially put the facts before the Charity Commissioner and asked him to give us specific instructions to admit those patients overriding our objections. We also warned the patients of facing very serious legal consequences for falsification of records in order to wrongly

avail the benefits under this Scheme. Realizing our stubbornness on the strength of right moral and legal grounds they all eventually backed out. We did this in pursuant of our pledge of ensuring that the really poor people of the Society get benefit from this scheme. We even gave extrastatutory benefits to these patients by providing facilities and food to the relatives of these really poor patients. Our best doctors also used to treat these patients, instead of the junior medical staff as was the practice in other hospitals. (Space constraints put restrictions on writing more elaborately on this topic.)


I will write more of such good governing practices in healthcare delivery against the dark reality in my subsequent articles.
