Election Commission to upgrade VTR sharing process

The Election Commission of India is now introducing a streamlined, technology driven system to provide timely updates on the approximate voter turnout percentage trends. This new process significantly reduces the time lag associated with the earlier manual reporting methods. The initiative aligns with the Commission's commitment to ensure timely public communication, which has often been underlined by the Chief Election Commissioner, Shri. Gyanesh Kumar on various occasions.

Under the statutory framework of Rule 49S of the Conduct of Elections Rules, 1961, Presiding Officers (PROs) are required to furnish Form 17C, detailing the account of votes recorded, to polling agents, who are nominated by the candidates and are present at the polling station at the close of poll. While this legal requirement remains unchanged, the process of updating the VTR App, which had evolved as a facilitative, non-statutory mechanism to keep the public informed of the approximate voter turnout percentage trends is being streamlined to ensure faster updation.

Under this new initiative, the Presiding Officer (PRO) of each polling station, will now be directly entering voter turnout on the new ECINET App every two hours on polling day in order to reduce the time lag in the updation of the approximate polling trends. This will be automatically aggregated at the constituency level. The approximate voting percentage trends will continue to be published every two hours as before. Notably, voter turnout data will now be entered into ECINET by PROs immediately after the close of poll, before they leave the polling station which will reduce the delays and ensure that the approximate percentage of votes polled would be available on the updated VTR App constituency-wise after the close of polls subject to network connectivity. Where mobile networks are unavailable, entries can be made offline and synced once connectivity is restored. This updated VTR App will become an integral part of ECINET before the Bihar elections.

Previously, voter turnout data was collected manually by Sector Officers and relayed to Returning Officers (ROs) via phone calls, SMS, or messaging apps. This information was aggregated every two hours and uploaded to the Voter Turnout (VTR) App. The polling percentage trends were often updated hours later, based on physical records arriving late in the night or even the next day, leading to delays of 4–5-hours or more leading to misperceptions by some.

Maharashtra cabinet unveils EV policy 2025 with tax waivers, toll exemptions and infra push

n a major step towards sustainable transportation, the state Cabinet on Tuesday approved the Maharashtra Electric Vehicles Policy 2025, aimed at boosting electric vehicle (EV) adoption and manufacturing across the state. The policy, which will be effective until 2030, includes a provision of Rs1,993 crore over the next five years for its implementation.

The policy focuses on expanding EV charging infrastructure, encouraging environmentally sustainable and innovative transport solutions, and enhancing energy security and economic growth. The state government anticipates a significant surge in the use and sales of electric vehicles as a result.

According to transport minister Pratap Sarnaik, "All electric vehicles sold and

registered in Maharashtra will be exempt from motor vehicle tax, registration certificate fees, and renewal charges. Charging stations will be set up at every 25 km along state and national highways.

Sarnaik also informed that subsidies will be given for vehicle purchase in the state. A 10% subsidy on the base price will be offered for electric two-wheelers, threewheelers, non-transport fourwheelers, state transport buses (M3, M4), and buses used in private, state, or urban transport services.

A 15% subsidy will be granted on electric goods vehicles including threewheelers, M1 category transport Contd. on Page 4

On March 13, 2025 the minister for Ports and Fisheries, Mr Nitish Rane, conducted the ground breaking ceremony for a jetty at the Gateway of India, Colaba, which left the residents of both Colaba and the city of Mumbai, absolutely numb. The jetty is being constructed between Radio Club and the Gateway of India.

The jetty will not be a standalone structure. This

area which is already brimming over with tourists will now have a giant jetty which will extend 650 meters into the sea. It will have an 80X80 platform which will house 150 car parks, lounges, toilets, ticket counters, cafeterias followed by a walkway 34 meters wide which will open out at the end into a badminton racket shaped structure. Step 7: Mobile Verification Add the beneficiary's mobile number and enter the OTP received on that number for verification purposes.

Step 9: Family Member Information Enter details of family members who may be eligible under the scheme and s u b m it the complete information.

Contd. from Page 1 amphitheater and 10 docks for anchoring boats on either side of the structure. This enormous jetty will rest on 137 piles dug deep into the sea.

No public hearing was held for a project which will impact the residents of south Mumbai deeply. There were numerous agitations by residents who spoke to the media, sought the help of politicians and wrote to the concerned authorities, including the Chief Minister, all to no avail. The residents repeatedly stressed that they were not against the project of the jetty, but requested the authorities to build it at Bhaucha Dhaka or Ferry Wharf or at Princess Docks. The residents pointed out that this was essential to protect both a heritage area like the Gateway of India and south Mumbai which is already reeling under an avalanche of tourists. vicious traffic snarls and unruly hawkers, many of whom are unlicensed.

A protest meeting was called by the residents of Colaba and Cuffe Parade. The Hon. Speaker of the Maharashtra Assembly and the MLA of the constituency, Mr Rahul Narwekar, assured the residents of his cooperation, along with South Mumbai MP, Mr Arwind Sawant and Mr Abu Azmi, who is a member of the Samajwadi party and a resident of the area.

Although all the politicians who attended the meeting assured the residents of their support, it appears the jetty will become a reality as the work of barricading on the pavements of Apollo Bunder, Colaba, is almost complete. Since there was no other option, no help from elected representatives and no way of meeting the Chief Minister, the residents knocked on the doors of the Bombay High Court and the Supreme Court.

Three Writ Petitions have been filed of which two have been heard but the order passed is not to the satisfaction of the petitioners. The next hearing at the Bombay High Court is on June 16, 2025. The citizens of south Mumbai have the support of the people of Mumbai, a city which is becoming more challenging to live in given the many surprises it holds for its citizens in the future.

Contd from Page 1 the project citing heritage and environmental concerns.

The PIL, filed through advocate Prerak Chaudhary, had sought an interim stay on the demolition of a wall and piling work already initiated at the site. However, the association did not receive any interim relief from the Bombay High Court or the Supreme Court.

Tushar Patole, executive engineer at the MMB, stated in the affidavit that the petitioners, under the guise of challenging permissions, are "effectively taking exception to a policy decision" that has been a decade in the making.

"The petitioner, claiming to represent local residents, is ignoring larger public interest and is seeking to obstruct the project on the basis of perceived personal inconvenience," the affidavit reads.

The project site is located near the Radio Club at Apollo Bunder, and not directly adjacent to the Gateway of India monument. The affidavit emphasised that the plan was revised from its original location — closer to the monument — after the Western Naval Command flagged serious security concerns.

"The Gateway of India, a symbol of strength and resilience, is a

Maharashtra to go fully solar in government offices by December 2025, CM Devendra Fadnavis announces major green push

n a major push towards sustainable energy, Maharashtra Chief Minister Devendra Fadnavis has announced that all

government offices across the state will transition to solar energy by December 2025. He also emphasized the effective implementation of the Pradhan Mantri Suryaghar Yojana to encourage solar power adoption at the household level.

The announcement was made at the inauguration ceremony of MahaUrja's new administrative building. MahaUrja, or the Maharashtra Energy Development Agency, will operate from a new green and potential target for terrorist attacks. The Navy recommended shifting the jetty near Radio Club to decongest the area," the affidavit said.

The MMB noted that the existing five jetties adjacent to the Gateway are over a century old and unable to handle the current volume of passengers approximately 30 to 35 lakh annually. One of the jetties is reserved exclusively for the Atomic Research Centre.

"The existing jetties are antiquated, unsafe, and lack basic infrastructure like proper berthing, waiting areas, emergency services, and frisking zones," said Patole. "Passengers, especially women, children, and the elderly, often risk injury while navigating multiple boats during boarding."

The new facility aims to segregate ferry commuters from tourists, ease vehicular traffic, and enhance safety. The MMB clarified that all necessary permissions have been secured, including clearances from the Maharashtra Coastal Zone Management Authority (MCZMA), State Environmental Impact Assessment Authority (SEIAA), traffic police, and the Heritage Committee. The matter is likely to be heard on June 16.

Save Powai Lake Group Cancels Silent Protest After BMC Demands ₹11,000 Fee

The Save Powai Lake group called-off their scheduled silent protest in form of human chain at the lake premises after the BMC asked the organisers to pay one-day event fee. "The ward office told us to pay Rs 11,000 for organising a protest. They also sent us a BMC circular justifying them ask for the nominal fee. It was shocking that a protest to protect a lake was considered as an event,' said environment activist, B N Kumar who leads the Save PowaiLake group.

As per the posters, the group had scheduled a 'Silent Human Chain' on Sunday, June 8 from 5 to 6 pm at Powai Lake Selfie Point. "We got permission from the police. But took rounds of BMC office for their NOC. Until Friday, we did not receive permission and on Saturday they sent us a 2015 Outdoor Contd. on Page 4

"They insisted payment for organising Silent Protest. Why should we pay for? It is not a Cold Play Event," Kumar said.

"It was astonishing and shocking as the Human Chain is not an activity that can attract an event fee. We are not holding a concert or any religious or cultural event," said Pamela Cheema, chairperson of Advanced Locality Management & AGNI Ward Coordinator.

"However, undaunted, we will continue the campaign -#SewerMuktPowaiLake - until all the sewer lines are diverted and sewerage treatment plant (STP) is set up. We will intensify our digital campaign with new messaging and involving all sections and the group will meet shortly to discuss other options," the activists added.

Kumar added that, all the promises by the authorities to clean the lake have remained only on paper and there is a semblance of action to clear hyacinth from the lake now, after the activists raised their alarm.

The activists had recently

started the SavePowaiLake online campaign. The BMC also acted fast and deployed additional machines and manpower to clear the hyacinth and unwanted vegetation from the Powai lake, which is damaging its biodiversity.

The BMC also came to conclusion that diversion of sewage lines is the only longterm solution to preserve Powai Lake. It also admitted that 18 million litres of sewage flows into Powai Lake daily and inflow of untreated sewage has led to an increase in water hyacinth.

On June 2, the BMC said in its statement that the draft letter (D.L.) for diverting the channels to prevent the entry of sewage into the Powai Lake has been approved. The acceptance of this tender (Date of Acceptance) and the issuance of work orders are expected to be done in the coming week. It also said that from May 23 to June 1 1,450 metric tons of hyacinth was been removed.

Contd. from Page 3 300 units, with the ultimate goal of eliminating electricity bills for these users.

Highlighting Maharashtra's pioneering role in the renewable energy sector, the Chief Minister said the state has installed over 5 lakh solar agricultural pumps in the last two years—more than any other state in India.

He also announced that under the Mukhyamantri Saur Krishi Vahini Yojana, solar power will be supplied to agricultural feeders with a combined capacity of 16,000 MW by 2026. This initiative represents Asia's largest decentralized solar energy project.

CM Fadnavis pointed out that electricity tariffs have increased by 9% annually over the past two decades. "Between 2025 and 2030, our aim is to bring down tariffs every year," he said, adding that the state's entire agricultural electricity demand will be met through solar energy by December 2026.

52% of Maharashtra's Power to Come from Renewables by 2030

Looking ahead, the Chief Minister said Maharashtra has signed a key agreement with a Russian government-owned company to develop thoriumbased energy generation technology. This move is expected to significantly enhance India's clean energy capabilities.

By 2030, Maharashtra aims to produce 52% of its electricity from renewable sources such as solar, wind, and hydrogen—drastically cutting down carbon emissions.

Contd. from Page 1 fourwheelers, light commercial vehicles (N2, N3), and agricultural EVs like electric tractors and harvesters.

To promote EV, the state government has decided to give toll exemptions to the Evehicles. "Full toll exemption for electric four-wheel passenger vehicles and buses on the Mumbai-Pune Yashwantrao Chavan Expressway, Atal Bihari Vajpayee Shivdi-Nhava Sheva Atal Setu, and the Hindu Hridaysamrat Balasaheb Thackeray Maharashtra Samruddhi Mahamarg. The loss of toll companies will be borne by the government," added Sarnaik.

A 50% toll discount will be provided to electric fourwheelers on other state and national highways under the Public Works Department.

The policy also introduces a clean mobility transition model, which targets a drastic reduction in carbon emissions, air pollutants, and greenhouse gases from the transport sector by 2030.
