## BOMBAY HIGH COURT DELIVERS LANDMARK JUDGEMENT IN POWAI LAKE CYCLE TRACK CASE

In a far-sighted judgement the Bombay High Court's verdict on May 6, 2022 on the Powai Lake cycle track case has not only saved the lake but will impact all judgements on the stressed environment of the country

ay 6, 2022 will be a memorable day for Mumbai when the Bombay High Court declared that "the work of the cycling and jogging track being carried out by respondent MCGM inside the

Lake, Mumbai and its catchment area." The Municipal Corporation of Greater Mumbai was directed to "immediately remove all construction carried out in furtherance of the cycling and



boundaries and the catchment area of Powai Lake is illegal and respondent MCGM is restrained from carrying out any reclamation or construction for the project of cycling and jogging track or for any other project inside Powai

jogging track......and restore all reclaimed sites to its original position."

This judgement is historic for the city as well as the Mumbai Metropolitan Region where wetlands are being constantly encroached Contd. on Page 4

Sandra Alex and I along with two other members represented ward 69. While most ALM members complained about irregular garbage collection, storm water drain cleaning, tree trimming and encroachment and also the menace of stray dogs, we complained about the random and free use of plastic bags and the influx of hawkers with hand carts. The meeting carried on for almost two hours, nobody was complaining about the same, everyone was eager to get their issues addressed and resolved.

## **BOMBAY HIGH COURT DELIVERS LANDMARK JUDGEMENT IN** POWAI LAKE CYCLE TRACK CASE

Contd. from Page 1 upon due to abysmal ignorance and shocking greed, with a cynical disregard for the well-being of the city and its surrounding areas.

Very importantly, Bombay High Court emphasised that though Powai Lake has been notified as a wetland in the National Wetlands Atlas "it essentially requires a notification. Powai Lake must and necessarily be notified to be a wetland in accordance with the notification dated 26<sup>th</sup> September 2017 issued by Ministry of Environment, Forests and Climate Change, Government of India, New Delhi."

Wetlands are crucial for Mumbai and according to a study conducted across the country by a non-profit, Wetlands International South Asia, which was published in January 2020 by Hindustan Times, among 22 Indian cities Mumbai has lost the most wetlands, about 71%, in 44 years from 1970 to 2014.

The learned judges at the Bombay High Court also

pointed out that in part VII of sub-regulation 3.3 of Regulation 34 in DCR 2034 a specific regulation for Powai and Vihar Lakes has been made which is that "in order to prevent erosion of soil and silting in lakes, an exclusive green belt of 100m shall be provided around the periphery of Vihar and Powai Lakes in which no construction whatsoever will be allowed."

The Judges were also not impressed with the use of 'Gabion Technology' for the construction of the cycle track and pointed out that MCGM had not filed any material to prove the success of the technology. Nor were they impressed by MCGM's claims of "rejuvenation and reinvigoration" of the lake after scrutinising photographs which showed land filling, reclamation, metallic frames being raised on the water body and the laying of a tar road at the periphery of the lake.

If the judgement of the Bombay High Court is historic, the two IIT Bombay students, Omkar Supekar and Abhishek Tripathi who filed the PIL, have blazed a path in activism which must be emulated in this

era of climate change. Omkar is studying for a PH.D in Indian philosophy and environmental ethics while Abhishek has just completed his PH.D in chemistry and is presently a Post Doctoral Fellow at the IIT.

The two young students live in Hostel No 13 facing the Renaissance Hotel across Powai Lake. They observed curious activities around the lake and finally discovered that the BMC was slowly entering the lake area. Intrigued, they questioned the police who blandly replied that no illegal activity was occurring in the lake. With no response from any authority to their queries, the students filed a PIL in the Bombay High Court on October 14, 2021. And the rest is history!

Did the students receive any support from the IIT? "Both yes



and Abhishek. "While we did not get any support from the IIT, we got moral support from the faculty and immeasurable support from our Guide, Professor K Ramasubramanian, Chair Professor, IIT Bombay. For money, we had to fall back on our Fellowship funds. We also had a very strong supporter in Shyam Saksena who lives in the Hiranandani Complex and helped us a lot with our documentation."

Both Omkar and Abhishek believe that "young people should not be afraid. This is the first ever PIL filed by any IITian across the country for an ecological cause. We are just two PH.D students who filed a PIL and received a favourable decision in just seven months. We now have to lead the way."
