A Think Tank BMC Elections 2022 committee of Mumbaikars and citizen groups across the city has been formed with Mr. Gerson daCunha as the Convenor. This committee will analyse, research, motivate, mobilize and guide the middle and upper middle (MUM) classes to participate in the coming Mumbai civic election and vote for good candidates with integrity, irrespective of the party to which they belong. If, however the parties don't put up clean and good candidates, Mumbaikars, who are now politically mature, will not hesitate to press the NOTA button on the EVMs.

In 2018, the State Election Commission, which is responsible for local civic elections in the state, passed an order that if NOTA gets the maximum vote in any constituency there will be a repoll in that constituency. (Order No. SEC 2018/NOTA/CR-10/Computerisation dated 06/11/2018)

The Order clearly states that all political parties in a workshop held on May 7th 2018 by the State Election Commission on the "Role of Political Parties towards a Healthier Democracy" expressed the opinion that NOTA should be treated as a "Fictional Electoral Candidate" and re-election should be held whenever NOTA gets the highest votes.

The BMC elections have the potential to give more quality to our daily lives than the Lok Sabha and Assembly polls: water supply, power, the BEST, roads, building permissions, primary health centres and hospitals, waste collection, markets, you name it, except for the Railways and Police which are central and state government subjects — the BMC rules. They have an annual budget of around Rs. 35,000/- Crores.

So with advance notice, political parties should start searching for good, non-criminal candidates amongst their leaders/workers for the BMC Elections 2022 to avoid the use of NOTA by Mumbaikars.



BMC Corporators performance dips in 2019-20 - Praja Foundation

Congratulations to the top three Corporators



The report card contains the performance of all the corporators besides the mayor. Out of the 227 elected representatives, the report card has ranked the performance of 220 corporators, excluding present Mayor Kishori Pednekar, Vishwanath . Mahadeshwar, who was holding the post of Mayor until November 2019 and 5 others who had been suspended or who died in the 12 month evaluation period.

The corporators have been judged on their academic qualifications, attendance in the assembly and committee conferences, the number of questions they asked, the significance of and the high quality of questions, and their utilization of the space improvement fund and the felony file.

There are 13 committees and out of the 13 committees, the common physique assembly is the one which has all of the 227

corporators as members and is scheduled each month. The standing committee, which has 27 corporators as members and approves and allocates funds required for varied tasks, is held each week.

The report discovered that the questions raised by the corporators in the various committees weren't in step with the complaints raised by residents. A complete list of 2,270 questions had been asked by the corporators in all of the 13 committee conferences together with the common physique. Out of the 270 queries 63 were related to drainage points.

In all 326 questions raised by the corporators were associated with highway repairs, potholes, lacking hyperlinks, whereas the renaming of roads and railway stations was the second most vital situation raised by corporators. "90 per cent corporators (199) contd. on Page 4

Contd. from Page 1 groups, would assemble at Aarey and prominent locations with Save Aarey placards and conduct Awareness campaigns,

The issue gained Citizens and public interest from 2015, when Metro Project was announced, which also said that there will be a Metro Car Shed for the Mumbai Rail Corridor at Aarey-Goregaon. We Citizens along with students decided, that we have to save the green patch and bio-diversity spread over 1300 hectares of land at Aarev.

The swift move by the Government to fell 2700 Trees at night, prompted Citizen campaigners like me, to rush to the heavily guarded site. Many of the protestors, were detained at night and early morning, by the state police force on duty, who forced protestors in Police vans, who were taken into custody, for defying sec 144 which was imposed.

Aarey is also a home for over 3500 Adivasi and Warli Tribal groups. Many families were forcibly shifted to SRA houses. We were concerned that the rich bio-diversity, which had taken decades to grow into a Forest, was being felled mercilessly.



The Government in power, further claimed, that Aarey is not a notified Forest. Citizens,

NGO's and Students could not accept this lying down and the protests grew in numbers, which spread across Mumbai City. The Activists clearly stated that they are not against Metro Depot, but MMRCL's choice of Aarey land for the same, many alternatives were given to the Government, including Kanjurmarg and six other locations. Newspapers and Media were flooded with Objections by the citizens, then the Government decided to call a Public meeting hearing on 8th July 2019, The MMRDA Auditorium at Bandra East, was packed to full capacity by the protestors, which included Students from Colleges across Mumbai, Save Aarey Citizen Teams, NGO's and more than 500 local Adivasi and Warli Tribals. It was announced at the meeting, that the Government,



had received 82,000 Objections, to prevent hacking of Trees.

All Activists and Citizens, Thanked Maharashtra **Environment Minister Aditya** Thackeray, when the notification was issued, which declared 600 acres of Aarev land as a reserved forest and also took up the issue of slum rehabilitation and the protection of Tribal rights. Aarev Metro Car shed will now be relocated at Kanjurmarg. Uddhav Thackerav Chief Minister, reiterated that the cases filed against Activists and NGO's who agitated and protested at Aarey Colony would be withdrawn. A big relief to students. Aditya Thackeray has been Congratulated for Saving Aarey, by All Activists, along with AGNI, for his role in protecting the green lung of Mumbai. A big Thank you for ensuring Development goes hand in hand with protection of Environment.

Contd. from Page 3 understand from where this deficit of 25% will be met. Is any minister/MP/MLA ready for a salary cut of this percentage? If not, then why should the public be put through this wringer, especially senior citizens? Perhaps it is because unlike you, we do not have the power to fix our own salaries, allowances and perks and be paid for a full year, for attending legislative sessions for a total of 3 months and that too, many legislators attend sessions at their own sweet will.

When the matter of increasing your own salaries is raised in parliament the same is passed in just 2 minutes with no discussion, with no opposition at all from the ruling or opposition benches. For this increase, you totally overlook the cost to the exchequer, the fiscal deficit, economics or any

other factor.

The government started a scheme for deposits of senior citizens and the rate was 9.20% but In July 2014 it was reduced to 8.3% which was further reduced to 7.4% in May 2020. Further, the ceiling for deposits has been limited to Rs 15 lakhs only. This is totally unjustified. The rate should be a minimum of 12% and the deposit limit should be equal to what a person gets as terminal benefits. The government should ensure financial security to senior citizens so that they can walk with their heads straight up.

I am sure you will understand the plight of people whose lifestyle is bolstered by the interest from their life time savings.

Contd. from Page 1 'Trolling' is being commonly used as a weapon against an opponent. The word 'trolling' did not even exist just a few years back! What is worse is that the opinion of the people seems to be getting polarised towards 'for' or 'anti' government, with political parties stoking these opinions.

There is also growing frustration among the common people with the whole governing system, resulting in a sizable number of people losing faith in the effectiveness of the system itself. This trend is very dangerous for democracy as it fosters extremism.

Is our governance as bad as the tsunami of negativity spewed by the social and electronic media make it out to be? If the answer is 'yes' and if the usual form of expression of people's dissatisfaction as mentioned above seems to be the only way to correct it, then we need to ask ourselves if the overall situation is hopeless.

And here comes the core of this discussion. The situation is certainly not as hopeless as it is projected to be. What then is the solution? An assertive citizen's movement for MAKING the governing system work for the benefit of its citizens while remaining WITHIN the system, in a non-agitational manner. Remain non-political with citizen centric emphasis. And most important of all, make full use of the existing laws which make governance transparent and functional.

Over the last 20 years there has been significant improvement in promulgating legal provisions for checks and balances on the government. Unfortunately, there is a high level of illiteracy about these provisions not only amongst the poor, but also among the educated and affluent.

Consider the example of 'The Maharashtra Right to Public Service Act, 2015' which seeks to create a mechanism to ensure timely delivery of goods and services to citizens. This Act provides that the citizens shall be provided services by the state government in a transparent, efficient and time bound manner. In order to ensure effective implementation of this Act, the Maharashtra State Commission for Right to Service has been established.

It requires every public authority to publish a Citizens Charter. The idea behind this Act is that citizens should be treated as 'customers' of the governing system by ensuring that the public services are responsive to the citizens they serve. There are a set of commitments regarding the standards of service it delivers. I will deal with this and many other legal provisions which are meant for ensuring good governance in a series of articles to follow.

These will be published in subsequent issues of Mumbai Meri Jaan, where I will discuss these legal avenues with examples and how they can work in favour of citizens. What is important is improving our governance instead of ranting about the lacunas in the system. This is precisely what AGNI is striving to achieve.

the loss or should I sacrifice consumption of medicines, atta, dals, vegetables, fruit, milk or what?

Practically the government after taking over in 2014 has done nothing for senior citizens. No additional facilities have been extended but on the contrary, there has been a withdrawal of what existed in 2014. No commodity or provision item is available at the price of 2014. Yes, you have been able to bring down the figures of inflation and indices, but not the actual prices.

Ever so often the prices of some essential daily-use items go rocket high like dals, chana/besan, salt, onions and now tomatoes. At such times we cannot even dare see those items. I know you have political and theoretical replies for these issues like interest on

deposits and advances in banks depend on demand and supply.

The prices of daily use items vary with seasons as they are agricultural products. But the manner in which prices are shooting upwards cannot be justified by these reasons. If the government wants to provide cheaper credit to traders and industries, it should not be at the cost of depositors.

Banks are in a precarious position because they are sitting on piles of NPAs and all good money is being diverted for bad money. But is it not the duty of the government to enable the senior citizens to lead respectable lives? After all they have spent their golden years in serving various organizations and the nation. The government cannot look the other way.

contd from page 1 scored less than 50 per cent when complaints made by citizens were correlated to the questions raised by corporators in 2019-20," stated the report.

"The quality of questions raised by corporators has also been poor, only 12% of the total 2,270 questions in 2019-20 were raised on water, sanitation and solid waste management issues, while 7% were raised on health. This highlights the poor deliberative focus of corporators on issues that most affect citizens", stated Milind Mhaske, Director, Praja Foundation.

The report card noted that corporators' attendance was the lowest in this 12 month period in contrast to the time period (2017-2020). The rating for attendance has fallen to 72.6% in 2020 from 80.7% in 2018 and 77.6% in 2019. The report additionally discovered that three corporators haven't asked a single question in this period i.e. since 2017.

While the corporators have welcomed the report card, the
