
he 12th National Conference of Resident Welfare Associations (12th NCRWA) is being held in Delhi this year.



## BMC's ward-wise fund allocation falls from 18% To 11% despite bigger 🖾 Desashri Bhujbal

budget

n startling data revealing the disparity of funds allocation by the Brihanmumbai Municipal Corporation (BMC) within its 24 administrative wards and the regions of Mumbai, over the past five years, while the BMC's overall budget has nearly doubled—from Rs 39,027 crore in 2021-22 to Rs 74,367 crore in 2025-26—the share allocated to wards has

The trend signals a growing gap in capital investment between overall city projects and local ward-level needs, with wards receiving a much smaller proportion of funds in recent years.

just 11%.

The data was released by the Praja Foundation, in collaboration with the Tata Institute of Social Sciences (TISS), which on Thursday launched its Report on the Ward-Wise Budget of Mumbai, highlighting the widening gap in budget distribution across the city, underscoring the urgent need to strengthen ward-level financial planning in Mumbai.

According to the report, if only the BMC budget of Rs 74,000 crore for 2025-26 is considered, the Island City allocates up to 37% of the total ward revenue expenditure for its population, which constitutes 24.80% of the total Mumbai; whereas 35% for a population Contd on Page 4

# **RBI's New Guidelines on Settlement of Deceased Customers' Accounts, Banks** to face penalties for delays

longside workshops and events, our advocacy continues to bring real change for citizens. That RBI has issued new rules making it easier for families to settle deceased customers' accounts. Over the years we've high lighted the difficulties families face - long delays, excessive document demands, and uncertainty even when nominations exist. Our advocacy and engagement with regulators has help push for these changes.

Under the new rules, nominees with valid nominations or survivorship clauses need only submit a claim form, death certificate and ID. For accounts without nominations, a graded approach simplifies claims up



to Rs. 15 lakh (commercial banks) or Rs. 5 lakhs (co=op. Banks). This is a big step forward and shows how collective action and persistent advocacy can lead to real change. This should make settling accounts smoother and less stressful for families at a difficult time. ## Cuffe Parade Residents Plan To Reclaim Section Of CPRA Greens **Garden Encroached During COVID-19**

he Cuffe Parade Residents Association (CPRA) plans to reclaim a section of the CPRA Greens garden on Captain Prakash Pethe Road that was fenced off by encroachers and rented out for events and festivals. The CPRA has been receiving warnings from the police and the BMC about noisy events on the plot, even as the association argued that encroachers had taken over the land.

#### **About The Case**

According to CPRA, the encroachers built an illegal wall across the garden during the COVID-19 epidemic, when security was lax. CPRA adopted the 1200 sq m plot to create a recreational space. While the rest of the plot has been converted into a garden,



the section along the busy road has been encroached. CPRA members said that when they confronted the encroachers, they were threatened by persons who boasted of their connections with local politicians. Laura D'Souza, president of CPRA, said that during Navratri, the plot was used for celebrations late into the night.

"I received calls from the police. Do you think I organised the event? If the plot has been encroached, isn't it the responsibility of the BMC and police to remove the encroachers?" stated D'Souza, Contd on Page 4

# Hospitals no better than business houses

ndia's healthcare system is on the brink of collapse, as acknowledged by the country's parliamentary committee. A recent investigation by Zee News reveals that approximately 44% of surgeries in India are either unnecessary, fraudulent, or performed with malafide intentions. This means nearly half of all operations are done solely to exploit patients or the government financially.

The report highlights alarming statistics:

- 55% of heart surgeries
- 48% of hysterectomies (uterus
- 47% of cancer surgeries
- 48% of knee replacements
- 45% of C-sections, shoulder replacements, and spinal surgeries are found to be unnecessary or fake in India.

A survey of prominent hospitals revealed that senior doctors are paid up to ₹1 crore per month. The reason behind this is that doctors who recommend more tests, treatments, hospitalizations, and surgeries—whether necessary or not—are rewarded with higher salaries.

The Times of India reported cases where hospitals treated deceased patients as if they were alive, billing them for unnecessary treatments and pocketing the money. In one instance, a hospital kept a 14-year-old boy on a ventilator for a month, claiming he was alive, before declaring him dead. The hospital was found guilty and fined ₹5 lakhs. But what about the mental trauma inflicted on the family?

Hospitals often perform surgeries on deceased patients, demanding payment from families and later claiming the patient died during surgery. This results in huge financial extortion.

The insurance (mediclaim) scam is equally alarming. While 68% of Indians have health insurance. claims are often rejected or partially settled, leaving families with significant expenses. Over 3,000 hospitals have been blacklisted by insurance companies for fraudulent claims.

During the COVID-19 pandemic, several hospitals were found to have created fake cases to claim insurance money. Human organ trafficking is another serious issue, with cases of illegal organ harvesting and trading coming to light.

The "hospital referral scam" is widespread, where doctors refer patients to specific hospitals for kickbacks. Some hospitals even offer monetary incentives for referrals.

The "diagnosis scam" is a massive industry, with labs and doctors involved in unnecessary tests and kickbacks. In Bengaluru, a raid on a pathology lab uncovered ₹100 crores in cash and 3.5 kg of gold, meant for bribing doctors.

Pharmaceutical companies spend thousands of crores on doctors to promote their drugs. During the COVID-19 pandemic, companies were found to have bribed doctors to prescribe their medications.

The hospital-pharma nexus is another issue, where hospitals provide cheap equipment and medicines to hospitals, but patients are charged exorbitant prices.

The Medical Council of India has failed to regulate doctors and hospitals effectively, despite rules and regulations. The council's guidelines, such as writing generic medicines, informing patients about treatment costs, and obtaining consent, are often violated.

Government schemes are also plagued by corruption, with hospitals and officials involved in billing for fake treatments.

Leader of the Opposition in Lok Sabha, Shri Rahul Gandhi cries hoarse about Adani and Ambani etc regularly for the last one decade. WHAT HAS HE TO SAY ABOUT HOSPITALS for taking innocent patients for a ride?

## **India's First Waste-To-Art Lab Coming Up In** Navi Mumbai's CBD Belapur

avi Mumbai is set to add another feather to its cap with the establishment of India's first 'Waste-to-Art Lab' at CBD Belapur. The Upcycling Art Training Centre, being developed under the Navi Mumbai Municipal Corporation's (NMMC) solid waste management initiative, will process around 200 tonnes of dry waste every month, turning discarded materials into artistic sculptures to enhance the city's beauty.

"Navi Mumbai has always been a pioneer in solid waste management and innovative recycling practices. This lab will not only help us manage waste efficiently but also promote creativity and environmental awareness," said Dr. Kailas Shinde. NMMC Commissioner.

As part of its ongoing innovation drive, the Upcycling Art Training Centre is being constructed beneath the Sector 21 flyover in CBD Belapur. "The corporation will provide the necessary infrastructure, while the contractor will install baling machines and other equipment required for processing," said Dr. Ajay Gadade, Deputy



Commissioner of the Solid Waste Management Department.

He added, "The sculptures created here will be displayed at public spaces across the city, contributing to Navi Mumbai's beautification. We will also conduct awareness sessions, workshops, and lectures for schools, colleges, housing societies, and corporate organizations to educate citizens on waste management."

Of the 200 tonnes of waste to be collected per month, officials informed that Contractors will purchase waste directly from sanitation workers and waste pickers for processing.

NMMC in the past has implemented projects that convert waste into useful materials — producing compost from biodegradable waste, industrial fuel pellets from plastic, coir ropes and cocopeat from coconut husks, and paver blocks from construction debris. The city also hosts India's first project to recycle old clothes.

The NCPI has also issued a video on the use of UPI Lite on smart glasses, which explains how a person can just 'Look. Speak. Pay'.

Contd from Page 1 of 44.42% in western suburbs and 28% budget for 30.78% population in eastern suburbs.

"The report highlights the importance of designing wardlevel plans that consider population growth, infrastructure needs etc. It raises a question about why important factors such as population and living conditions are disregarded while planning for the city's budget," said Sitaram Kunte, Advisor, Praja Foundation & Former Chief Secretary, Maharashtra.

As per the report, the top three wards in total expenditure (revenue + capital) and average per capita from the year 2021-22 to 2023-24 are A ward (Colaba, Cuffe Parade); B ward (Dongri, Masjid) and C ward (Marine lines, Kalbadevi). While the bottom three are R-North (Dahisar), R-South (Kandivali) and K-East (Andheri, Jogeshwari, Vile Parle East).

The top wards providing the civic amenities such as storm water drains, solid waste management, roads, open spaces/gardens etc include A (Colaba, Cuffe Parade); B ward (Dongri, Masjid); C ward (Marine lines, Kalbadevi); T

While the bottom wards in the civic amenities include R-North (Dahisar); R-South (Kandivali); M-East (Govandi, Mankhurd); H-East (Bandra, Juhu, Santacruz East); L (Kurla) etc.

#### Some of the key highlights from the report are:

-The Island City, despite having just 25% of Mumbai's population, records the highest per capita revenue expenditure.

-The Western Suburb, home to the largest share of the city's population (44.42%), receives the lowest per capita revenue and capital expenditure, highlighting a disparity between population size and allocation of resources.

-The Eastern Suburb, with 30.78% of the population, secures the highest per capita capital expenditure, suggesting a stronger focus on infrastructure and developmental projects in this region.

Contd from Page 2 who added that the caretaker agreement ended in 2019 and has not been renewed since then. Assistant superintendent of gardens (BMC) S K Aware, said that he will report the matter to the seniors. "We will take action as per procedure. However, the wall did not come up suddenly; it has been there for the last four or five years. I have spoken to the residents. As adopters, it is the final responsibility of the residents' association to report on the construction of the wall," said Aware.

D'Souza said that when they confronted the encroachers. they were mocked. "If the agreement has not been renewed, how are residents responsible for encroach-

ment and the noise? There are clinics, a college, and other institutions around the plot, which make it a silent zone," D'Souza added.

CPRA stated that the encroached plot is not marked in the Development Plan 2034, making it vulnerable to diversion for uses other than as an open recreation area. On October 3, Padmakar Nandekar, CPRA vice president, wrote to the 'A' municipal ward office about their plans to demolish the wall on October 8 and have asked for police protection. The office of Rahul Narwekar, the local MLA and Maharashtra Assembly speaker, whose name is displayed on banners erected on the plot, did not respond to calls.

## State, central co-op banks under ombudsman

Contd from Page 1 co-operative banks with deposits size of INR 500 million and above.

All non-banking financial companies, excluding housing finance companies, which can accept deposits and have assets of INR 1 billion and above also come under the ombudsman scheme. The central

bank had introduced the integrated ombudsman scheme to provide customers of regulated entities a speedy, cost-effective, alternative grievance redress mechanism.

RBI plans to empower ombudsman to award up to '30 lakh compensation to aggrieved bk customers

The RBI released draft master directions for the Internal Ombudsman for regulated entities, as well as the draft norms for the Integrated Ombudsman Scheme, 2025. The central bank has sought public comments on both by Oct.

According to the proposed directions for the Internal Ombudsman for regulated entities, a firm must have one internal ombudsman. The internal ombudsman should not be a current or past employee of the entity and must have at least seven years of experience in areas such as banking, and non-banking finance. As per the draft guidelines for the Integrated Ombudsman Scheme, the RBI can appoint one or more of its officers as ombudsman for three years. This scheme was first launched in November 2021 and provides quick, cost-effective, and expeditious alternate grievance redressal mechanism.

The draft directions said there is no limit on the amount in a dispute that can be brought before the ombudsman. "However, for any consequential loss suffered by the Complainant, the Ombudsman shall have the power to provide a compensation up to 30 lakh," the draft norms said.
